ARTICLES OF INCORPORATION

OF

THE CUT EDGE SERVICE COMPANY

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is: The Cut Edge Service Company

ARTICLE II. PRINCIPAL OFFICE


