## ARTICLES OF INCORPORATION

## THE STATE ROOM, INC.

The undersigned, for the purpose of forming and organizing a corporation for profit under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

### ARTICLE I - NAME

The name of the corporation is THE STATE ROOM, INC.

### ARTICLE II - PURPOSE
