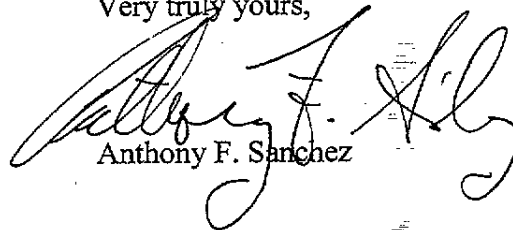

## ARTICLES OF INCORPORATION

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: The name of this corporation is:

ARTICLE II: The principal office of the corporation shall be 1400 N.W. 12<sup>TH</sup> Avenue, Miami, Florida 33136. The corporation will also maintain a separate mailing/billing address which shall be: 16820 S.W. 52<sup>nd</sup> Place, Fort Lauderdale, FL 33331.
