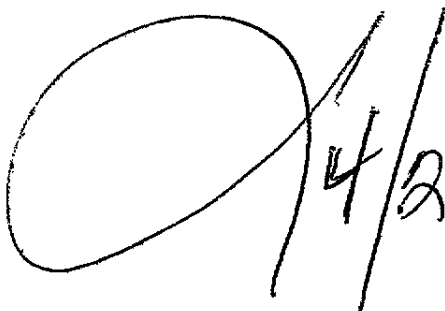

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: Curtis J. Herbert, P.A.. The address of the principal office of this corporation shall be 10081 Pines Blvd., Suite E, Pembroke Pines, FL 33024 and the mailing address of the corporation shall be the same.

ARTICLE II. PURPOSE OF CORPORATION

The general purpose for which the corporation is organized is:

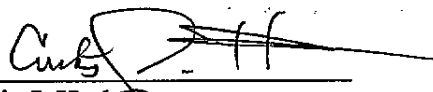

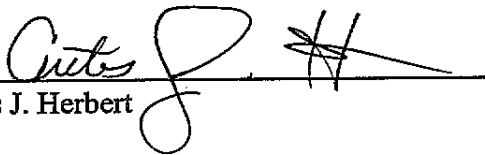
