ARTICLES OF INCORPORATION
OF
AMERICAN COMPUTER INNOVATORS, INC.

ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be AMERICAN COMPUTER INNOVATORS, INC. The principal and mailing address of the corporation shall be 7407 33rd Avenue South, Tampa, Florida 33619.

ARTICLE II - NATURE OF BUSINESS

The business is being formed for the purpose of computer sales, repairs and any other services as may be authorized by law.

ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue one thousand (1000) shares of capital stock of the par value of One Dollar (\$1.00) which shall be designated "Common Shares," and all of which shall have the same rights and privileges.

ARTICLE IV - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of the Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
