

# ARTICLES OF INCORPORATION OF GUARDIAN ANGELS CHILDCARE, INC.



#### ARTICLE I

# NAME AND PRINCIPAL OFFICE

The name of this corporation is Guardian Angels Childcare, Inc. The mailing address of this corporation's initial principal office is 770 SW 12th Avenue, Pompano Beach, Florida 33069.
