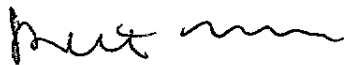

ARTICLES OF INCORPORATION
OF
FLEET SERVICES OF FLORIDA , INC.

ARTICLE I - NAME

The name of this corporation is FLEET SERVICES OF FLORIDA, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on March 25, 1999.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing consulting services for painting , fleet maintenance and performing contractual obligations and for transacting any or all lawful business as allowed under the laws of the State of Florida.
