ARTICLE I - NAME

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on March 24, 1999.



This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida General Corporation Act.





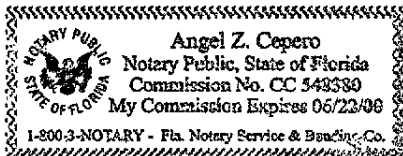
