ARTICLES OF INCORPORATION

99 MR 30 MII. 29 The Undersigneds, acting as incorporators of a corporation un the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is THRILL HILL MINING, INC.

ARTICLE II - NATURE OF BUSINESS
