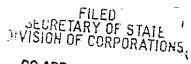

THE UNDERSIGNED, for the purpose of forming a corporation, under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

#### <u>ARTICLE I</u> NAME OF CORPORATION

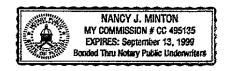
