The undersigned, acting as the incorporator of the Corporation under the Florida Professional Services Corporation Act, adopts the following Articles of Incorporation for such Professional Services Corporation:

**ARTICLE I**  
**NAME OF THE CORPORATION**

The name of this Corporation shall be Weiss Legal Group, P.A.

**ARTICLE II**  
**PERIOD OF DURATION**

The period of duration of the Corporation is perpetual.

**ARTICLE III**  
**PURPOSE**

The general nature of the business to be transacted by this Professional Services Corporation is to engage in any and all business customarily performed by licensed attorneys at law in accordance with Chapter 454, Fla.Stat., and in accordance with the Florida Professional Service Corporation Act.

**ARTICLE IV**  
**LIMITATIONS ON RENDITION OF PROFESSIONAL SERVICES**

Professional services rendered through this Professional Service Corporation shall be performed only through its officers, employees and agents who are duly licensed as attorneys and counselors at law by the Supreme Court of the State of Florida.

**ARTICLE V**  
**AUTHORIZED SHARES**

**Number:** The aggregate number of shares that the Corporation shall have the

authority to issue is One Thousand (1000) shares of Capital Stock at no par value.

**Issue:** One Hundred (100) shares of the Capital Voting Stock of the Corporation shall be issued for adequate consideration in the following manner:

**100 Shares to Kevin Weiss**

No capital stock shall be issued to any individual other than an individual who is duly licensed or otherwise legally entitled to render professional services as an attorney and counselor at law by the Supreme Court of the State of Florida.

**ARTICLE VI**  
**REGISTERED OFFICE AND AGENT**

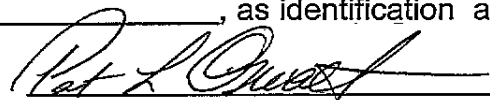
