#### **ARTICLE I – Name and Principal Office**

The name of this corporation is **DEVStudios, Inc.** The principal office of this corporation is: **13575 – 58<sup>th</sup> Street North, Suite 200, Clearwater, FL 33760.**

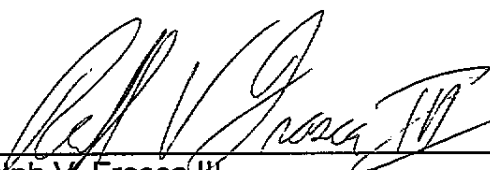
ARTICLE VIII – Indemnification
