The undersigned natural person, who is licensed or otherwise legally authorized to practice medicine in the State of Florida, hereby notifies all people of the State of Florida that he intends to form a professional corporation in accordance with the *Florida Professional Service Corporation Act*, Chapter 621, *Florida Statutes* (1999), and hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I. NAME**

The name of the corporation is: RUDY R.D. BOGOIAN, III, M.D., P.A.

**ARTICLE II. EFFECTIVE DATE AND DURATION**

The effective date of the incorporation shall be the date that the Articles of Incorporation are filed in the Office of the Secretary of State. The period of the corporation's duration shall be perpetual or until lawfully dissolved.
