We, the undersigned, do hereby subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

ARTICLE ONE

The name of this corporation shall be:


#### ARTICLE ELEVEN


## ARTICLE TWELVE


