ARTICLES OF INCORPORATION

Medical Auctions, Inc.

The undersigned incorporator, a natural person competent to contract, for the purposes of fortning a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be Medical Auctions, Inc.
