- ARTICLE 1. NAME The name of the corporation is International Training Institute, Inc.
- ARTICLE 2. PRINCIPAL OFFICE AND ADDRESS The address of the principal office of the corporation is 500 South Lakeview Dr. Lake Helen, Florida 32744
- ARTICLE 3. DURATION The duration of the corporation is perpetual: and the corporate existence will commence on the filing of these articles by the Departement of State.
- ARTICLE 4. PURPOSE The purpose of the corporation is as follows:
- A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statues. It is not organized for the private gain of any person. The specific purpose of the corporation is:
 - A1. To create a nondenominational ministry
 - A2. To create an association of ministries
 - A3. To establish and maintain houses of worship throughout the world
 - A4. To teach the gospel of our Lord Jesus Christ throughout the world

- A5. To train and ordain ministers
- A6. To train and ordain missionaries
- A7. To train and ordain medical missionaries
- A8. To establish and maintain medical clinics throughout the world.
- A9. To establish and maintain educational schools of all grade levels in third world countries.
- A10. To establish and maintain Christian Academies throughout the world.
- A11. To train personnel as medical care givers
- A12. To perform other related religious and/or educational functions allowed under the guidelines of a not-for-profit corporation
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations
- C. Provided, however the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to

these people for services rendered, and to make payments and distributions in futherance of its stated purpose.

ARTICLE 5. MEMBERS The corporation shall have no voting members

ARTICLE 6. INITIAL REGISTERED AGENT AND OFFICE. The initial registered agent is Daniel H. Bennett and the initial registered office is 151 East Ohio Lake Helen, Florida 32744

ARTICLE 7. INITIAL BOARD OF DIRECTORS The board of directors shall have four members who are.

The bylaws shall provide the method of election of all directors, and the number of directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

ARTICLE 8. OFFICERS the officers of the corporation shall consist of a President, Secretary, and Treasure. Other officers may be provided for in the bylaws. Each officer shall be elected by the board of directors(and may be removed by the board of directors) at such time and in

such manner as may be prescribed by the bylaws. The name and address of each initial officer is as follows;
