The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be CGS ADVERTISING GROUP, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 918 Bradshaw Terrace, Orlando, Florida 32801.

ARTICLE III - DATE OF EXISTENCE

This Corporation shall exist perpetually, commencing on the date of execution of these Articles of Incorporation.
