ARTICLE I-NAME

The name of this Corporation is PRESTIGE COMMERCIAL CLEANING, INC.

ARTICLE II-DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

ARTICLE III-PURPOSE

This Corporation is organized for the following purposes:

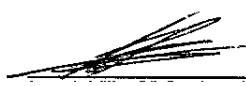

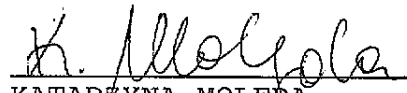
