Dear Sirs,

I sent you a letter in December concerning the reinstatement of my corporation. I asked that you waive the penalty for not filing on time due to not receiving the notification.

I received notification back that my request was denied.

Respectfully, I am writing again to ask you to reconsider my request. Very importantly I take full responsibility for the lack of filing and blame no one.

However, this was the first year I was to pay this fee. I was not aware that I had to pay this by any such date. I do understand now that the corporation fee is due on January 1 of each year with a late penalty occurring after May.

I do not recall receiving any information regarding this fee for the year 2000. Perhaps I did not know what it was and inadvertently discarded it. You can believe I am aware of it now. Letter or no letter I will pay my dues ahead of time.

Also, I did receive notification around September, I think it was. At that time I think the fee was to be \$550.00. Since I was confused, I decided to speak to my accountant to inform me of what this was pertaining to. I was unable to schedule a visit because of being out of town for business.

Then I was detained out of town for another month because my little brother was shot in the head. I know this seems very hard to believe and perhaps far fetched. But you may verify this if you desire. His name is Doug and he was a patient at Pitt County Memorial Hospital in Greenville, North Carolina for over 30 days. And yes, he is still alive.

So, with business and personal reasons I had a very strange and busy year. To my dismay, when I finally spoke to my accountant I learned of my error in not paying the fee on time. What simply was \$150.00 turned into \$750.00.

I have definitely learned a lesson and will never allow this to happen again. At the same time, however, I would like to ask one more time for you to consider my request. I am sending the check again with the hope that you will understand and know that I was not purposeful in not sending it sooner.
