
In preparing our Uniform Business Report for the year 2003, we were surprised that the corporation was administratively dissolved for the annual report referenced. In speaking to one of your representative, we learned that penalty will be levied for reinstatement. We find this to be very steep and the school is not in a financial position to pay the fines. The truth of the matter is that we never received the initial UBR or subsequent notices.

We operate in an economically deprived area and the mail boxes are frequently broken into and contents removed. As a result, we have asked all our creditors and some of the more frequented governmental agencies to redirect our mails. However, in downloading a copy of the corporate registration, we found the original mailing address unchanged.

In light of this, we piteously ask that you forego the late fee and reinstate us for just the on-time filing fees. Please find enclosed \$300 to cover years 2002 and 2003.
