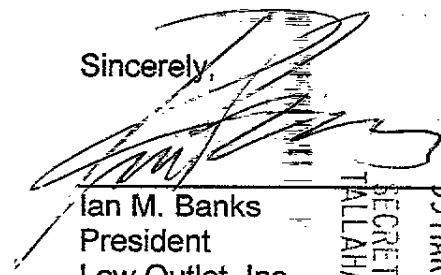

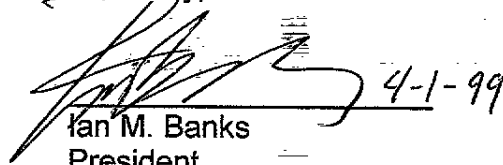

# Articles of Incorporation for Law Outlet, Inc.

The undersigned Incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

## Article I Corporate Name

The name of this corporation is Law Outlet, Inc.

## Article II Principal Office & Commencement of Corporate Existence

The principal place of business and mailing address of this corporation shall be 1902 W. Jetton Ave., Tampa, FL 33606.

This corporation shall come into existence on the date of subscription and acknowledgement of the Articles of Incorporation.

## Article III Capital Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall be one thousand (1,000) shares of common stock, each with a par value of one dollar. Each share issued and outstanding common stock shall entitle the holder thereof to one vote on each matter with respect to which shareholders have the right to vote, to fully participate in all shareholder meetings, and to share ratably in the net assets of the corporation upon liquidation or dissolution.

## Article IV Initial Registered Office and Agent
