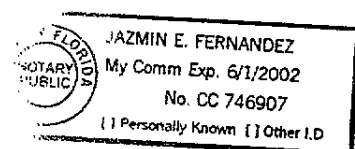

In general, this corporation may, without restriction, perform any and all acts and functions permitted by law.

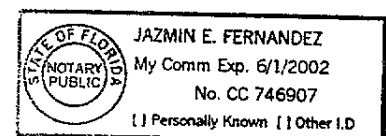
ARTICLE IV - CAPITAL STOCK

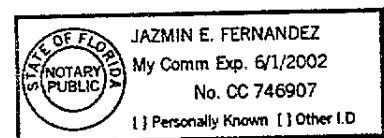

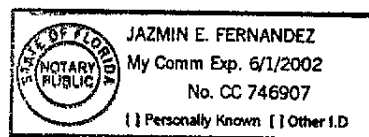


