Article I - Name

The name of the corporation is: **David C. Walker, D.C., P.A.**

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose

This corporation will engage in the practice of Chiropractic Medicine as permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

Article IV - Capital Stock



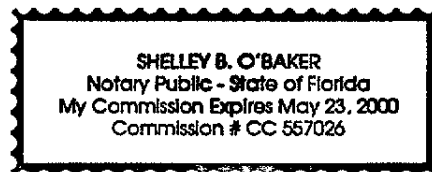


