

ARTICLES OF INCORPORATION

OF

DEEN DESIGNS, INC.

ARTICLE I - NAME

The name of this corporation is **DEEN DESIGNS, INC.**

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

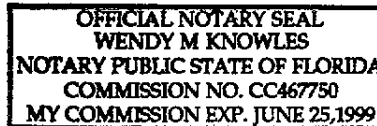


