#### ARTICLE I - Name

The name of this corporation is JAMES GILBERT LAWN SERVICE, INC.

#### ARTICLE II - Purpose

This corporation is organized for the purpose of lawn service, maintenance and landscaping.

#### ARTICLE III - Capital Stock

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock.

#### ARTICLE IV - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

### ARTICLE V - Initial Registered Office and Agent
