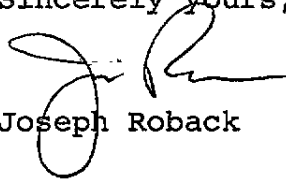

## ARTICLES OF INCORPORATION

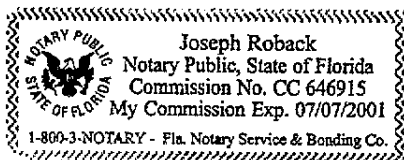
