FOR

ARTICLE ONE

The name of the corporation is Desktop Concepts Inc.

The period of its duration is perpetual.

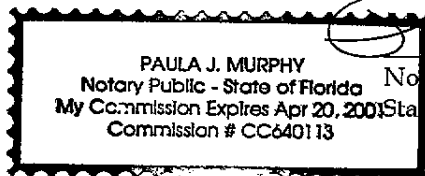




