Article of Amendment to Articles of Incorporation for E-MAX Group, Inc.

Purstlatt to the provisions of Section 607.1006, Florida Statutes, the Stiders of corporation adopts the following articles of the amendment to its articles of incorporation.

First, Amendment adopted:
