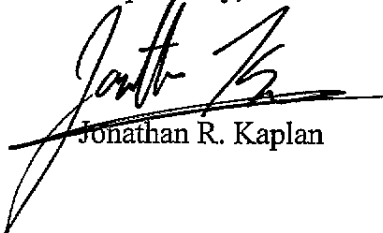

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a for profit business corporation.

ARTICLE I - NAME

The name of the corporation is **JORDAN WRECKER SERVICE, INC.**
(hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The corporation is formed to engage in wrecker and towing services under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 100 shares of Common Stock, par value \$1.00 per share.

ARTICLE IV - INITIAL REGISTERED AGENT

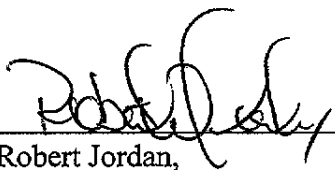
