**ARTICLES OF INCORPORATION OF  
WESLEY H. OWENS, P.A.**

The undersigned, who is duly licensed to practice law in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following articles of incorporation:

**ARTICLE ONE. CORPORATE NAME.** The name of the corporation is Wesley H. Owens, P.A.

**ARTICLE TWO. PURPOSE.** The purpose for which the corporation is organized is the practice of law.

**ARTICLE THREE. ELECTION UNDER PROFESSIONAL CORPORATION ACT.** The corporation elects to be governed by the provisions of the Florida Professional Service Corporation and Limited Liability Company Act.

**ARTICLE FOUR. DURATION.** The period of existence of the corporation is perpetual.

**ARTICLE FIVE. PRINCIPAL OFFICE AND MAILING ADDRESS.** The principal place of business and mailing address of the corporation is 4000 St. Johns Ave., Suite 11-M, Jacksonville, Florida 32205.

**ARTICLE SIX. REGISTERED OFFICE AND REGISTERED AGENT.** The initial registered office is at 4000 St. Johns Ave., Suite 11-M, Jacksonville, Florida 32205. The name of the initial registered agent at that address is Wesley H. Owens.

**ARTICLE SEVEN. AUTHORIZED SHARES.** The corporation is authorized to issue five hundred shares of common stock having no par value.

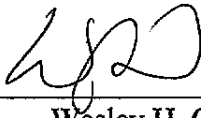
