ARTICLES OF INCORPORATION

OF

THIES AND ASSOCIATES, INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE Name

The name of the corporation is: THIES AND ASSOCIATES, INC.

ARTICLE TWO Principal Office

The street address of the initial principal office of the corporation is 390 South Tyndall Parkway, #126, Parker, Florida, 32404.

ARTICLE THREE Corporate Duration

The duration of the corporation is perpetual.

ARTICLE FOUR Purpose or Purposes


