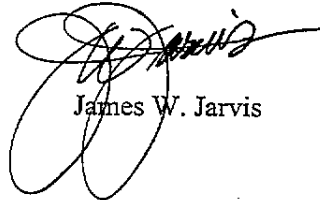

OF

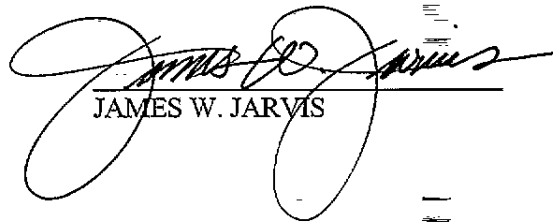

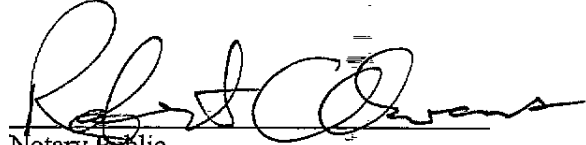

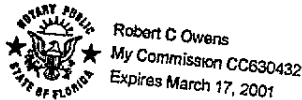
