# AMENDMENTS TO ARTICLES OF INCORPORATION of JASCO CONSTRUCTION COMPANY

A Florida For Profit Corporation

The following Amendments to the Articles of Incorporation duly adopted pursuant to the authority of Chapter 607, of the Florida Statutes and the existing articles of Jasco Construction Company, a Florida corporation, supersede and take place over such provisions of the existing Articles of Incorporation which were filed with the Secretary of State on April 6, 1999, and any other amendments to date.

## ARTICLE IV : REGISTERED AGENT

## ARTICLE VII OFFICERS

The Board may remove any or all of the officers from office, with or without cause, and at such time as the Board may determine.
