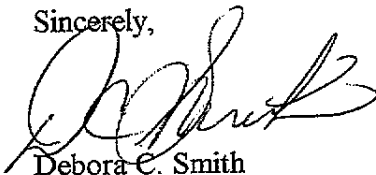

ARTICLES OF INCORPORATION

OF

The undersigned, acting as Incorporator of a corporation under the laws of the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation as follows:

ARTICLE I

Name. The name of the corporation shall be: **THE MASTERS HANDS TRANSPORTATION, INC.**

ARTICLE II

Duration. The period of its duration is perpetual.

ARTICLE III

Purpose. The purpose is to engage in any activities of business permitted under the laws of the United States and of Florida.

ARTICLE IV

Capital Stock. The corporation shall have authority to issue 750 shares of stock, all of one class, at One Dollar (\$1.00) par value.

ARTICLE V

Initial Registered Agent and Principal Office. The mailing address and street address of the initial registered office and principal office of the corporation is: **1115 Teakwood Ave., Tampa, FL 33613**, and the name of its initial registered agent at that address is **JOAN W. STONE**.

ARTICLE VI

Initial Board of Directors. The number of directors constituting its initial board of Directors is (2), whose names and addresses are:

Indemnification. The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

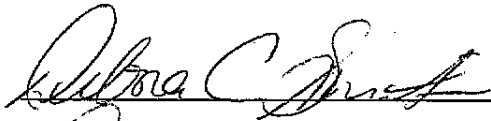

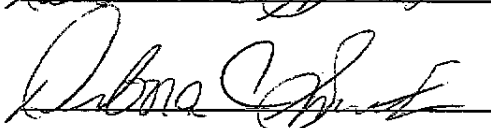
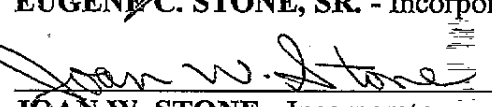
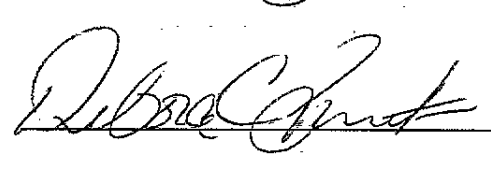

ARTICLE X

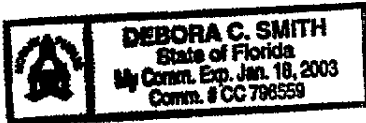

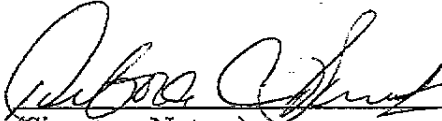
