





ARTICLES OF INCORPORATION
FOR
LAJATA PUBLISHING, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I. CORPORATE NAME.

The name of the corporation shall be:

LAJATA PUBLISHING, INC.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business of this Corporation shall be:

ARTICLES III. COMMENCEMENT OF CORPORATE EXISTANCE

The Corporations shall com into existence on March 29, 1999.

ARTICLE IV. PURPOSE.

The general purpose for which the Corporation is organized is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE V. AUTHORIZED SHARES.

1. The aggregate number of shares which the Corporation is authorized to issue is One Hundred (100) shares of Common Stock, each share having the par value of one dollar (\$1.00). The Common Stock shall be of a single class. Such shares of Common Stock shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution.

2. The Board of Directors of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

ARTICLE VI. REGISTERED AGENT AND OFFICE.

ARTICLE XII. PREEMPTIVE RIGHTS.


The Corporation elects to have preemptive rights, pursuant to Section 607.0630, Florida Statutes, as amended from time to time.


