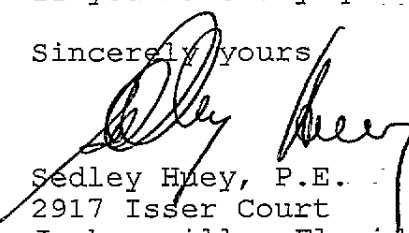

ARTICLE 1

Name of Corporation: The name of the corporation shall be Acktel Electric Company Incorporated.

ARTICLE II

General Nature of Business: The general nature of the business and the objects and purposes proposed to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do namely:

(a) To manufacture, purchase, or otherwise acquire, hold, own, mortgage, pledge, sell, assign, and transfer, or otherwise dispose of, invest, trade, deal in and deal with goods, wares, and merchandise, and real and personal property, corporeal and incorporeal, of every class and description; and apparatus of all kinds.

(b) To establish and maintain offices to conduct commercial transactions involving goods, shares, merchandise, commodities, and other property of any and all kinds.

(c) To take, lease, purchase, or otherwise acquire, and to own, use, hold, sell, convey, exchange, lease, mortgage, work, improve, develop, divide, and otherwise handle, deal in, and dispose of real estate, real property, and any interest or right therein.

(d) To borrow money and from time to time, to make, accept, endorse, execute, and issue bonds, debentures, promissory notes, bills of exchange, and other obligations of the corporation for monies borrowed, or in payment for property acquired, or for any of the other objects or purposes of the corporation of its business, and to secure the payment of any such obligations by mortgage, pledge, deed, indenture, agreement, or other instrument

of trust, or by other lien upon, assignment of, or agreement in regard to, all or any part of the real or personal property, interest, rights, franchises, or privileges of the corporation, wherever situated, whether now owned or hereafter to be acquired; and to sell or otherwise dispose of any or all such bonds, debentures, or obligations, in such manner and upon such terms as may be deemed judicious.

(e) To provide professional services, including, but not limited to electrical engineering.

(f) To provide contractual services, including, but not limited to electrical construction.

ARTICLE III

Capital Stock: The maximum capital stock of this corporation shall be ten thousand (10,000) shares of common stock with par value of \$0.10, all to be issued fully paid and exempt from assessment.

The capital stock will be paid for in property, labor, or services at a just valuation to be fixed by the stockholders or by the directors of the corporation at the organization meeting had, after the granting of the charter herein applied for or at any regular or special meeting of the corporation in which capital stock shall be sold, issued, assigned and transferred only in accordance with such by-laws as the corporation may, from time to time, make change or alter.

ARTICLE IV

Corporate Existence: This corporation shall have perpetual existence unless dissolved according to law.

ARTICLE V

Principal Place of Business: The principal place of business of this corporation shall be 126 West Adams Street, Suite 450, Jacksonville, Florida 32202 with the privilege of having branch offices or other places within or without the State of Florida, or within or without the United States of America.

ARTICLE VI

Directors: The Board of Director(s) of this corporation shall consist of not less than one member nor more than nine in number.

ARTICLE VII

Name(s) and Address(es) of Director(s): The name(s) and post office address(es) of the first board of director(s), who, subject to the provisions of this Certificate of Incorporation, the By-Laws, and Statutes of the State of Florida, shall hold office for the first year of the corporation's existence, or until their successors are elected and qualified, are as follows:

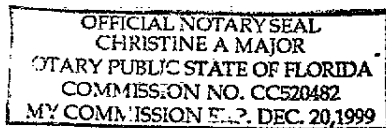
