ARTICLE I. NAME. The name of the corporation is J. D. NEAL PROFESSIONAL DEVELOPMENT, INC. with its principal place of business at 4656 Pompano Street, Placida, FL 33946.

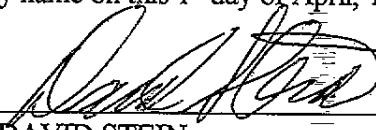

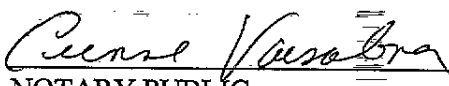
