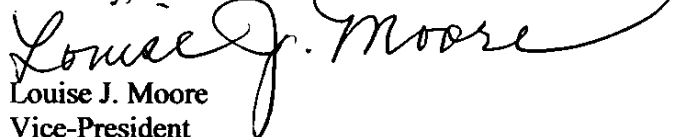
Dear Sir or Madam,

May 8, 2008

I am the Vice-President and sole office employee of our corporation. Yesterday I was balancing our bank account and discovered that check # 1028, made out to Florida Department of State for \$150.00, has not cleared our account. There is no entry for a tendered check that was refused for insufficient funds either. I called this situation to the President of MCH Squared Enterprises, Inc., Lee Hagler, and he became alarmed. We have not had the envelope with the Annual Report and check returned to sender either. Although I made a copy of the report for our records it is not in its file and I have not been able to locate it. I do have a copy of the check that I wrote on April 1, 2008. It isn't very clear because it is the carbon entry of the check. We don't know if we should stop payment on the original check and issue a replacement or see if it got diverted in your mailroom or misplaced. Another issue that I faced was not receiving an Annual Report Notice. When this notice failed to arrive we thought it was because we had paid our fee a month in advance and your division processed our report and check and saw there was no need to send us a reminder.

When I downloaded a duplicate 2008 For Profit Corporation Annual Report I was shocked to see that our current filing fee is \$550.00. We feel that we should be exempt from penalties because we filed 30 days in advance of the deadline and would not have even been aware of our lost documents had I not recognized that the check made out to you did not clear nor was submitted to our bank. To expedite matters I am going to reissue a check, stop payment on #1028, and include another Annual Report. I thank you in advance for your attention to this matter.
