The name of this corporation is Home and Auto Insurance Agency, Inc.





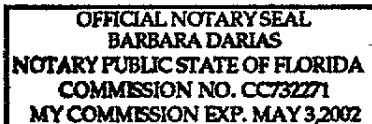
