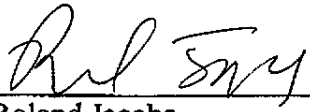
ARTICLES OF AMENDMENT FOR UNISMART INC.

- 1) The name of the corporation is UniSmart Inc.
- 2) Article III. Capital stock is hereby amended to read as follows:

The maximum numbers of share of stock this corporation is authorized to have outstanding at any one time is ten million shares of common stock at one dollar per value. All existing shareholders shall be issued a new certificate evidencing their ownership of their shares of common stock, which will be equal to their current ownership percentage of the outstanding stock of the corporation. Provided however, as an exception, to the statement above, Roland Jacobs shall be issued stock reflecting an ownership percentage of 52.50 percent, which is a reduction from his current percentage of 75 percent, thereby providing the authorized stock for issuance to new shareholders.

- 3) This Amendment is adopted as of this 16 day of August 2000.
- 4) The Board of Directors has adopted this Amendment, without shareholder action and shareholder action for the adoption of this Amendment is not required.
