ARTICLES OF INCORPORATION OF DRK IMPORT-EXPORT CORPORATION



The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I.
