The name of this corporation shall be John A. Wright Painting, Inc.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles.

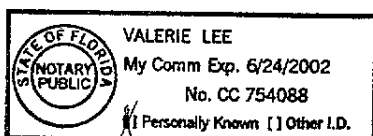



