Articles of Incorporation *of* **SPECTRA, INC.**

Article I - Name

The name of the corporation is: Spectra, Inc.

Article II - Duration

This corporation shall exist perpetually.

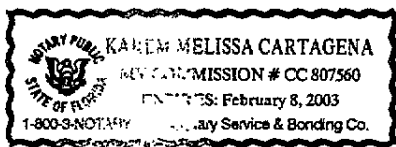
