**ARTICLES OF INCORPORATION  
OF  
CAROL C. RODRIGUEZ, P.A.**

**Article I  
Name**

The name of the professional corporation is CAROL C. RODRIGUEZ, P.A.

**Article II**

**Duration**

This professional corporation shall have a perpetual existence.

### **Powers**

### **Indemnification**

Such indemnification shall continue as to a person who has ceased to be a director, officer, employee or agent, and shall inure to the benefit of the heirs and personal representatives of such person. An adjudication of liability shall not affect the right to indemnification for those indemnified.

## **Article XI**

### **Amendment**

This professional corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

## **Article XII**

### **Bylaws**

The bylaws may be adopted, altered, amended or repealed by either the shareholders or the Board of Directors, but the Board of Directors may not amend or repeal any bylaw adopted by shareholders if the shareholders specifically provide such bylaw is not subject to amended or repeal by the directors.
