She told me about a scam from a corporation and asked for the amount of the check. I told her it was for \$100.00 and she told me that that was the price that this corporation was charging, and the charge for the State of Florida was actually \$150.00.

In researching this information, I found that the check had not been cashed. I put a stop payment on the check, and check the State of Florida website regarding what the Attorney General was doing regarding this corporation. I found out that they found this corporation committed consumer fraud and made them return the money of the checks cashed and return the checks that they had not cashed as of yet. I waited a few weeks to see if my check would be returned to me, because basically that was the only proof that I had paid this corporation in error instead of the State of Florida. The only other proof that I had that I paid this money was the check register showing the date and amount of the check.
