*The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:*

**ARTICLE I NAME**

*The name of the Corporation is FELTEL CORPORATION.*

**ARTICLE II**

*The principal place of business and mailing address of this Corporation shall be:*

**ARTICLE III DURATION**

*The period of his duration is perpetual.*

**ARTICLE IV PURPOSE**

*The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.*

**ARTICLE V CAPITAL STOCK**

*The Corporation shall have authority to issue 5000 shares all of one class, at .10 par value.*

**ARTICLE VI INITIAL REGISTER AGENT**

*The address of its initial registered office is 13206 S.W. 131 STREET, MIAMI, FL. 33186, and the name of its initial register agent at said address is FELIX TELLEZ*

**ARTICLE VII BOARD OF DIRECTORS**

*The initial Board of Directors shall consist of two (2) Directors, whose name and address are:*

ARTICLE IX PREEMPTIVE RIGHTS

Preemptive rights shall be as follows:

1.- Shareholders of the Corporation shall have preemptive rights to acquire their pro rata share of stocks of the Corporation for all issues of any class of stock of the Corporation, no matter when authorized, and for whatever consideration is contemplated to be received by the Corporation, including but not limited to cash, other property, services, the acquisition of other Corporation shares or property through merger or extinguishment of debts. Preemptive rights shall apply to the reissuance of all redeemed or otherwise acquired shares, including the re-issuance of treasury shares.

2.- The article pertaining to preemptive rights may not be amended or deleted without the unanimous vote of the shareholders of each affected class.

3.- No issue of stock of the corporation shall take place unless the price at which the stock is to be issued shall be unanimously approved by the shareholders of the Corporation.

4.- These preemptive rights shall apply to any corporate obligation which is convertible to or exchange for any stock of the Corporation, or where there is attached to said obligation any stock warrants or rights which allow the holder to acquire by subscription or purchase any stock of the Corporation.


ARTICLE X AMENDMENTS

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholder's meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all the Stockholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.
