Due to the above, we request that you accept the \$150 to file the Uniform Business Report for 2002.

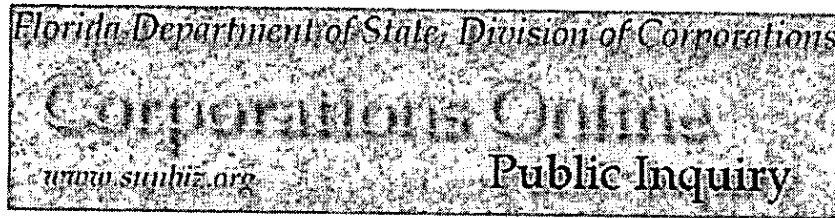
