ARTICLES OF INCORPORATION

OF

STRANE & ASSOCIATES, INC.

ARTICLE I - NAME

The name of this corporation shall be STRANE & ASSOCIATES, INC.

ARTICLE II - PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.
