1. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

**ARTICLE I**

**Name of Corporation**

The name of this Corporation shall be Kyndal Ann Beavers, M.D., M.P.H., P.A. (the "Corporation").

2. Article II of the Articles of Incorporation is amended to read as follows:

**ARTICLE II**

**Mailing Address**

The principal place of business and mailing address of this corporation is 4700 N. Congress Avenue, Suite 303, West Palm Beach, Florida 33407.

3. This Amendment was recommended by the board of directors to the Corporation's shareholders on February 5, 2001, to be effective as of January 1, 2001.
