# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, Hereby adopts the following Articles of Incorporation:

# ARTICLE I - NAME

The name of this corporation is MALIK & JAHANZEB, INC.

#### <u>ARTICLE II – PURPOSE</u>

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the State of Florida and the United States of America. This shall include, but not be limited to retail sales.

#### ARTICLE III – CAPITAL STOCK

This corporation is authorized to issue Ten Thousand (10,000) shares of \$1.00 par value common stock.
